ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION FOR HICKORY CLUSTER ASSOCIATION

The Amendments are as follows:

a. Subparagraph (c) (3) of Paragraph 3 of the Articles of Incorporation is hereby deleted in its entirety. This subparagraph reads as follows:

"Only a member of the Corporation (other than the Developer of Reston and any assignee or subsequent assignee of its membership) residing in the dwelling unit with respect to which he is entitled to vote, shall have the right to vote."

b. The seventh sentence in Paragraph 4 of the Articles of Incorporation, which sentence is the penultimate sentence of subparagraph 4 and begins with the words "Any vacancy . . .", is hereby struck and the following is inserted in place of the same:

In the event of death, resignation or removal of a single director, that Director's successor shall be selected by the remaining members of the Board and shall serve until the next members' meeting at which Directors are elected, at which meeting an election shall be held to fill out the unexpired term. If more than one vacancy occurs at the same time among the Directors, successor Directors shall be selected through a special election by the Members to serve the unexpired term of their predecessors.

c. Add a new paragraph to the end of the Articles of Incorporation:

7. The Bylaws of the Corporation may be amended, at a regular or special meeting of the members, only by a vote of more than two-thirds (2/3) of the votes of all members.
