- Block 3 Resident reminded board members of the National Night Out on August 3rd
- Block 2 Resident discussed railing specifications for rebuilding and repairs. Board discussed need to follow HCA/RA and county specification
- Block 2 Resident discussed planting in planters and need for common standards for plants
- Block 3 Resident asked about a poplar tree needing significant trimming or removal due to multiple dead branches and a pine tree that should be cut as it is too close a home
- Block 1 Resident asked about the status of the carriage house parking legal review status
- Block 3 Resident asked about Reston Association DRB involvement in roof replacement
- Block 2 Resident discussed mailboxes, grounds maintenance, moving a Dogwood tree and replacing with smaller tree/shrub

OFFICER REPORTS AND OTHER BUSINESS

- Directors reviewed approved July financial report
